### INFORMATION TO CUSTOMERS AND CONSENT

#### Disclosure pursuant to Regulation U.E. 2016/679 and implementing provisions

Pursuant to art. 13 of the U.E. Regulations 2016/679 (hereinafter Regulation) and implementing provisions, and in relation to personal data of which BE.MA.TEX SRL will come into possession by virtue of the relationship established with you, we inform you of the following :

**2. Purposes of data processing.** The treatment is finalized solely at the correct and complete execution of the contract.

**3. Legal basis and legitimate interest**

The legal basis of the treatment consists of the contract stipulated with BE.MA.TEX SRL The data may also be processed on the basis of the legitimate interests of the owner, in order to comply with legal obligations (for example health and social assistance).

**4. Methods of data processing.**

a) Processing can be performed with or without the aid of electronic or automated tools; b) the processing is carried out by the owner and/or authorized to the treatment, in particular employees and/or collaborators, internal and/or external, of BE.MA.TEX SRL the treatment will include all the operations or set of operations envisaged by art. 4 n. 2 of the Regulation and necessary for the treatment in question and precisely: the collection, registration, organization, structuring, storage, adaptation or modification, extraction, consultation, use, communication by transmission , diffusion or any other form of making available, comparison or interconnection, limitation, cancellation or destruction

**4. Provision of data.** The provision of common, sensitive personal data is strictly necessary for the purposes of carrying out the activities referred to point 1.

**5. Refusal to provide data.** Except for the obligations deriving from current regulations, any refusal by the interested party to provide personal data implies the impossibility of fulfilling the activities referred to point 2

**7. Data communication.** Personal data may be disclosed to the persons in charge of processing and may be communicated for the purposes referred to point 1 to all public and private entities to whom communication is necessary for the correct fulfillment of the purposes indicated in point 2. Data processing it will also take place for the purposes of the current anti-money laundering legislation.

**8. Dissemination of data.** Personal data are not subject to disclosure.

**9. Transfer of data abroad.**

Personal data in general are not transferred to third countries for the purposes referred to in point 1. If this requirement should arise, the interested party will be informed whether or not there is a decision on the adequacy of the EU Commission and in any case an explicit consent will be collected.

**10. Data retention period**

The data will be kept for the period necessary for the performance of the activity and in any case not longer than ten years from the termination of the relationship.

**11. Rights of the interested party. We also inform you that in relation to the aforementioned data you will be able to exercise the rights envisaged by the Regulations (article 14 and following) and the related implementation measures.**

In particular, will be entitled:

- - to obtain access to your personal data and information on
  - ✓ the purposes of the processing, the categories of personal data processed, the recipients or categories of recipients to whom the personal data have been or will be communicated,
  - ✓ the retention period of the personal data provided
- - to ask the data controller or the responsible person to rectify or delete personal data or limit the processing of personal data concerning him or to object to their processing, if they are no longer necessary for the purposes of processing or unlawfully processed. This right is not admissible if there is a legal or contractual obligation or a legitimate interest or if the data are necessary for the assessment, exercise or defense of a right in court.

These rights are exercised with a simple communication, also via e-mail, to the address of the TTD indicated above. The reply will be provided to you, in an intelligible form, preferably by e-mail, at the latest one month from the request, unless you propose a complaint, if you believe that your rights or that the procedure have not been respected, to the Guarantor on the protection of personal data (contact details at [www.garanteprivacy.it](http://www.garanteprivacy.it))

However, I will have the right to obtain, with a motivated and documented request, the correction or integration of data, if inaccurate or incomplete. This fulfillment will be executed without delay, after verification of the request. In some cases it may also require that the treatment be limited, if the conditions provided for by the law are met (procedure to ascertain the accuracy of the data, illicit treatment, need to use data to assert a right, verification of legitimate interest.

For the data processed with automated systems will also have the right to receive, if requested to the above addresses, in a structured format, of common use and legible personal data concerning you provided by you in order to communicate them to another holder (portability right).
